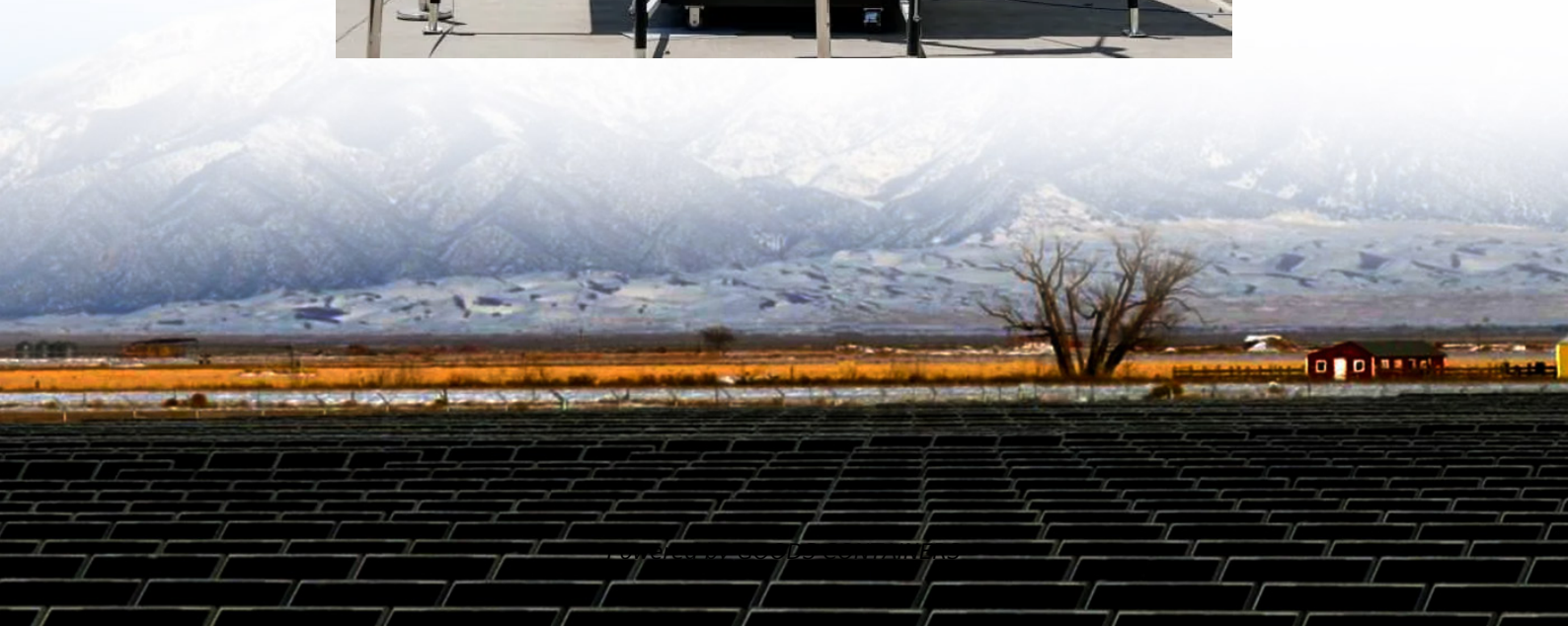


Is solar container outdoor power suitable for foreign trade





Overview

How can PV industry participate in international trade?

Next, consider that manufacturers in PV industry can also participate in international trade by paying iceberg trade cost τ , and that exports of Chinese PV products to the West can also be subsidized by Europe and the USA for PV products.

Are Chinese PV exports sustainable?

In the short term, they led to a noticeable and substantial decrease in Chinese PV exports to Europe and the United States. In the long term, the negative impact on Chinese PV exports is not sustainable. The above conclusions are verified as reliable after multiple robustness tests.

Do trade restrictions affect Chinese PV exports?

It is based on Chinese PV trade data (HS 8-digit coding) from 2009–2019 and trade policy data from the World Bank's Temporary Trade Barriers Database. The study reveals that trade restriction policies have significantly negatively impacted Chinese PV exports, with adverse effects exhibiting temporal heterogeneity.

How does China's PV industry respond to external challenges?

In contrast, China insisted on breaking through trade barriers with technological innovation. This starkly contrasting choice of paths ultimately prompted the Chinese PV industry to successfully respond to severe external challenges, demonstrating strong resilience in industrial development.

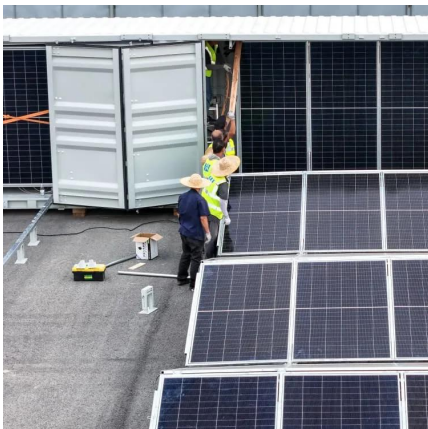

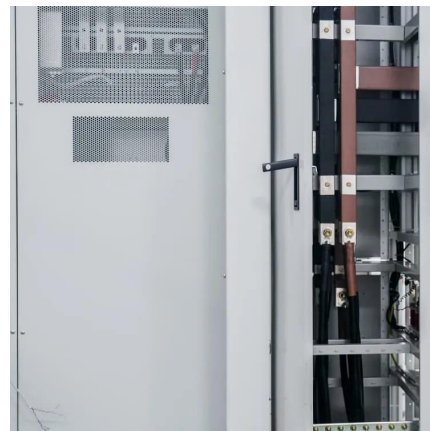
