

Solar glass companies investigated





Overview

The European Commission recently announced the initiation of a second anti-dumping and countervailing duty sunset review investigation into solar glass originating in China, following applications filed by Interfloat Group, i.e., Interfloat Corporation, and GMB Glasmanufaktur Brandenburg GmbH on April 18 and 19, 2025. How can manufacturers defend profitability in the Solar Photovoltaic Glass market?

Manufacturers now compete on scale, logistics efficiency, and coating innovation to defend profitability in the solar photovoltaic glass market. Cumulative solar capacity reached 1.6 TWdc in 2023, up 89% on 2022, while building-integrated photovoltaics (BIPV) gained momentum.

Which companies were investigated under the FSR in 2024?

On 3 April 2024 the European Commission launched two in-depth investigations under the Foreign Subsidies Regulation (FSR). The two companies involved were ENEVO, which includes LONGi Solar Technologie GmbH, as well as Shanghai Electric UK Co. Ltd. and Shanghai Electric Hong Kong International Engineering Co. Ltd.

How does uncertainty affect the Solar Photovoltaic Glass market?

The resulting uncertainty defers investment decisions and tempers the growth trajectory of the solar photovoltaic glass market. In 2024, anti-reflective coatings commanded 57% of the solar photovoltaic glass market, supported by entrenched float infrastructure and proven light-capture gains.

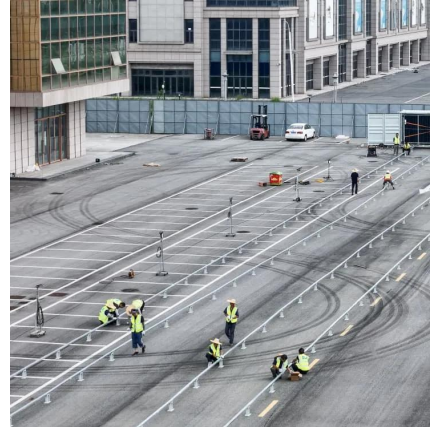
