What is a solar panel government subsidy?

A solar panel government subsidy is like a financial boost from the government to help you afford solar panels. These subsidies, which may include tax credits, rebates, or grants, aim to make renewable energy more accessible to homeowners and businesses.

Do you qualify for government subsidies for solar panel installation?

To qualify for government subsidies for solar panel installation, applicants must meet specific conditions: The solar panel system must be installed by a vendor registered under MNRE or the state's DISCOM-approved list. It should be a grid-connected rooftop solar panel system. Only domestic (residential) users are eligible for subsidy support.

Can a solar panel subsidy be limited to 10 kW?

There is a possibility that a subsidy on a solar panel can be limited to the maximum capacity of 10 kW. The Indian government has come up with various solar panel schemes to provide to the enterprises that are promoting growth. CFA totaling INR 2 M/MW or 30% of the project's cost. This also includes grid-connectivity costs.

What is solar panel subsidy scheme in Karnataka?

The Indian Government solar panel scheme in Karnataka is a bit different than other states. This scheme is called 'Surya Raitha (Solar pump) subsidy scheme. If a farmer uses a solar pump in their field for farming activities the state government will provide subsidies to farmers.

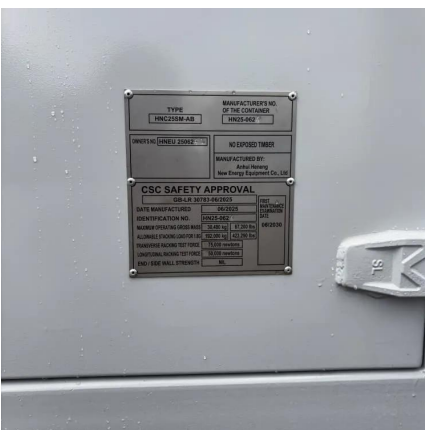

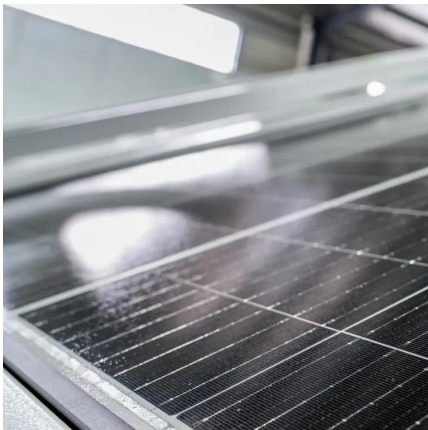
